Scrip Program Agreement

Bloomington Living Hope sponsors a Scrip program which allows you to purchase Scrip cards which in turn generates rebates from participating retailers. These rebates can be used as a credit to your tuition account, tuition assistance, or miscellaneous account. The parties agree as follows:

Please note that if nothing is marked, monies will automatically go toward Tuition Assistance.

Account Information:

Account updates are available through your family account at www.shopwithscrip.com. We encourage you to manage your own account. If assistance is needed, please contact the Scrip administrator at blhscrip@myblh.org.

Your tuition credit account will remain open unless there is no activity in a 12 month period in which case the balance will be turned over to Tuition Assistance.

In the event your family accumulates more than your tuition obligation for your last child's eighth grade year, the remainder of the tuition credit in the account may be transferred to another Family, otherwise it will be applied to Tuition Assistance.

If a situation arises and your child does not attend BLH (moves, switches schools, etc.), the tuition credit will be applied to Tuition Assistance.

In the event of a death or divorce, the right to make the tuition credit designation decisions may be as ordered by the appropriate court.

Your Scrip tuition credit account will NOT earn interest.

Purchasing Process:

Scrip purchases must be paid for at the time of ordering and may be paid with cash, check, or PrestoPay.

Scrip cards and certificates are the same as cash and should be handled accordingly.

In order for a Scrip purchase to be credited to an account, the Scrip purchase must be designated to a particular account holder at the time of purchase. Scrip purchasers may designate a Scrip purchase to any person's account, but only the account owner may designate how the tuition credit is used.

Program Notes:

With respect to your charitable contributions, we will provide the required acknowledgements under sections 170 (f) (8) and 170 (f) (17) of the Internal Revenue Code. We urge you to consult your tax advisor as to any questions or advice regarding the deductibility of charitable donations.

You agree to indemnify BLH against any loss incurred in connection with there being sufficient funds in your account to cover the checks or ACH transfers you issue to pay for Scrip. If a check is returned because of nonsufficient funds (NSF), a \$30 fee payable to BLH will be charged. Scrip ordering privileges will be limited to cash only after 2 NSF checks are tendered on an account.

Circumstances requiring interpretation of the plan guidelines will be decided by the then-current coordinator of the Scrip program. This agreement continues unless replaced by another and can be terminated by either party upon notice to the other.
